



## Instructions for Atikameksheng Trust Mail-In Nomination for Resident Trustees and Non-Resident Trustee

1. The Original Nominator will nominate Atikameksheng Anishnawbek band member(s) for Atikameksheng Trustee by completing the Trust Mail-in Nomination Form then complete & sign the "Declaration of Mail-In Nomination Form".
2. Next the Seconder signs the Trustee Mail-In Nomination Form. The space to sign is immediately below the space for the nominators signature.
3. If you would like to nominate more than two nominees for Resident Trustee and more than one nominee Non-Resident Trustee, please photocopy another "Trustee Mail-In Nomination" form for use.
4. Both the Original Nominator and the Seconder must be registered with Atikameksheng Anishnawbek and be 18 years of age or older.
5. Both must then fill out a "Declaration of Mail-In Voter to Nominate Trustee" form. There are two (2) forms and are copied back-to-back.
6. Place the "Mail-In Nomination" form and the "Declaration Mail-In Voter to Nominate Trustee" forms in an envelope, then mail to:
